

VILLAGE OF LAKEVIEW
REGULAR COUNCIL MEETING MINUTES
October 10, 2023

President Griffith called the meeting to order at 7:00 p.m.

AGENDA APPROVAL: Trustee Fryover moved and Trustee Trevino seconded to approve the agenda as amended. Parking lot cap with Shook was added as item a. Motion carried.

PUBLIC COMMENTS: Ethan Sack, 531 S. Lincoln, had a question about blight. Manager Dood addressed the question and stated that there are certain items that are not considered blight.

Manager Dood presented Lieutenant Russell's report. He noted that the Police department has been very busy lately.

DPW Supervisor Bucholtz gave a brief rundown of his report. He was asked where he prefers to have the leaves placed for pick up. He said it is easiest for pickup if they are in the road next to the curb. All on one level works best with the vac hose.

OIC Nielsen presented his report. They will be working to repair a leak on Washington Ave. in the near future.

Manager Dood mentioned we received a few more applications for the DPW position. He will be holding interviews next week. The Mini truck will likely be delivered this week Thursday or Friday. A Tri-annual inspection of the water tower will take place next week.

BUSINESS**Parking Lot Cap**

The original parking lot bid was to place a second layer of asphalt on the new section of the lot. If the entire lot is capped versus the new section only, there will be less seams and will ultimately extend the life of the parking lot.

Trustee Fryover moved and Trustee Leppink seconded to approve the added cost to the Asphalt layer for Lakeside Parking lot. Motion carried.
