

VILLAGE OF LAKEVIEW
REGULAR COUNCIL MEETING MINUTES
May 13, 2025

President Griffith called the meeting to order at 7:00 p.m.

Members Present: President Griffith, Trustee Trevino, Trustee Behrenwald, Trustee Mitchell, Trustee Leppink and Trustee Fryover.

Members Absent: Trustee Carlson

Also Present: Manager & Chief Darin Dood, Officer Evans, OIC Nielsen and Clerk Melissa King.

AGENDA APPROVAL: Trustee Behrenwald moved, and Trustee Mitchell seconded to approve the agenda as presented. Motion carried.

PUBLIC COMMENTS: Marcy Myers, 203 Macomber, stated that there are encroachments on some of the properties within the Village limits. She noted that there are also unapproved alleys or streets within the Village, along with utility right of ways and wondered if they could be added to the properties that have encroachments to help with this issue.

STANDING ITEMS

Trustee Behrenwald moved, and Trustee Leppink seconded to approve the meeting minutes from April 8, 2025, as presented. Motion carried.

Trustee Griffith moved, and Trustee Trevino seconded to approve the closed session meeting minutes from April 8, 2025, as presented. Motion carried.

Trustee Fryover moved, and Trustee Mitchell seconded to approve the bills in the amount of \$135,121.32 as presented. Motion carried.

REPORT

Manager Dood presented the Lieutenant's report. With an additional officer on in the evenings, our numbers have increased. He noted all Police Officers will be on this weekend for the Gus Macker Tournament.

Manager Dood presented Supervisor Bucholtz's report. Nothing was added.

OIC Nielsen presented his report. Nothing was added.

Manager Dood presented his written report. With the Macker Tournament happening this weekend, he gave a rundown of the parking areas, especially those associated with the

wedding that will be taking place on Saturday evening at Tamarack Place. Manager Dood is putting together a brief that will be posted on the Village Facebook page that states the roads that will be closed, areas for parking and other events that are taking place during the tournament. Manager Dood, along with Fire Chief Carr, are working on hard barricades for the public's safety. Chris Fryover, along with his crew, have volunteered to put together the basketball hoops. At approximately noon on Friday, the hoops will be placed for the tournament. Food trucks will be placed on the Kelsey lot along with a Fire Truck for the kids to visit. We have two 40-yard dumpsters and roll away carts for trash and our DPW will be working all weekend to help where needed. Manager Dood feels everything was well planned out and he stated our community came together to get it done.

The PUD at Tamarack Meadows Resolution #2025-06 that was approved last month at the Village Council meeting, went to the Brownfield Authority and they made the recommendation to the full board for approval. Once it is approved by the board, it will then go to the Planning Commission.

Trustee Leppink has been in contact with a gentleman named Joe Rodriguez from Utah who is the President of the United States Ice Fishing Division. Joe thinks Lakeview Michigan; home of the US Ice Fishing Team, has a nice ring to it. Don't be surprised if you hear a little more about the US Ice Fishing Team coming back to Lakeview. Not the international event, but possible qualifying events.

NEW BUSINESS

Museum Discussion

The Museum is working on expanding their building and adding a restroom to the property. They are asking for a donation of the water/sewer connection fee from the Village of Lakeview to help with this expansion.

Trustee Behrenwald moved, and Trustee Fryover seconded to donate the connection fee to the Museum. Motion carried.

Trustee Trevino moved, and Trustee Fryover seconded to adjourn the meeting at 7:23 PM. Motion carried.
