**REGULAR COUNCIL MEETING MINUTES**  
**May 14, 2024**

President Griffith called the meeting to order at 7:00 p.m.

**AGENDA APPROVAL:** Trustee Fryover moved and Trustee Behrenwald seconded to approve the agenda as amended. Environmental RFP was added under new business. Motion carried.

**STANDING ITEMS**

Trustee Fryover moved and Trustee Trevino seconded to approve the meeting minutes from April 9, 2024 as presented. Motion carried.

Trustee Leppink moved and Trustee Mitchell seconded to approve the bills in the amount of \$149,263.63 as presented.

**REPORTS**

Lieutenant Russell added that the afternoon position has been filled in the police department.

Supervisor Bucholtz noted the tree planting in the right of way is complete. When asked if the sidewalk work is complete, Supervisor Bucholtz and Manager Dood stated that there is still a lot of work to be done grinding and replacing. Work will not start on sidewalks until after Summerfest.

OIC Nielsen added the new equipment the Council approved has been essential in the day-to-day operations. He also noted that the total discharge should read 6,677,000 on his monthly report.

Manager Dood touched base on the purpose of the Greenville Transportation Committee. This committee discusses road projects that are current or projected. Road improvement cost has increased significantly in recent years. Therefore, funding for these projects will be changing in the near future.

Trustee Behrenwald moved and Trustee Fryover seconded for the Village Manager to complete the bidding process for Environmental RFP and subsequently permit the Village Manager to accept the lowest bid. Motion carried.

**ADJOURN:** Trustee Trevino moved and Trustee Behrenwald seconded to adjourn the meeting at 7:36 PM. Motion carried.
