REGULAR COUNCIL MEETING MINUTES
August 13, 2024

AGENDA APPROVAL: Trustee Saxton moved and Trustee Mitchell seconded to approve the agenda as presented. Motion carried.

PUBLIC COMMENTS

Trustee Behrenwald moved and Trustee Saxton seconded to approve the bills in the amount of \$141,634.86 as presented. Motion carried.

REPORTS

Lieutenant Russell presented his report. He was asked how officer Campbell likes his position with the Village. He stated he loves it and we love having him on board.

Supervisor Bucholtz presented his report. He was asked how the scheduling for brush worked. He noted that we pick up the first week of every month. If there are numerous piles out, they will get the chipper out and take care of them if time allows. This is doable now that we own the chipper and do not share it with a neighboring community.

OIC Nielsen presented his report. Nothing was added.

Manager Dood added to his report. The dog fence bottom bracing at Wiseman Park and the Well House fencing is scheduled for install starting August 26, 2024. These items were already budgeted for.

Manager Dood has been doing comparisons for health insurance coverage.

The event on Saturday, Fighting Childhood Cancer, raised over \$20,000. This was a great event and was well attended.

Manager Dood was contacted by the World Series Ice Fishing organization. They are looking at holding the event on Tamarack Lake in February. More information to follow.

BUSINESS

Trustee Saxton has resigned his position on the Village Council. Manager Dood thanked him for his time serving on the council and sub-committees and for his time and effort he put into starting the bike trail. We appreciate all his time he has put into our community. It's people who care about this community that make it what it is.

Trustee Trevino moved and Trustee Fryover seconded to accept the resignation of Trustee Saxton. Motion carried.
