

Cato Township Meeting Minutes 5/09/22

Call to order by Gilbert 7 PM

Present –Gilbert, Grieser, Lindsey, Lincoln and Behrenwald

Absent- None

Also present 8 community members

Motion by Grieser supported by Lindsey to approve April Minutes, all in favor, carried

Public comment on Agenda items, add Zoning Board of Appeals appointment 8 d.

Monthly bill detail provided by Clerk, motion to approve and pay by Lindsey supported by Grieser, discussion on bills regarding Lakeview Community Schools election addressed, all in favor motion carried

Treasurers report given by Treasurer, motion by Lincoln supported by Behrenwald to accept as presented, Discussion on Delinquent Property Tax, not settled with County yet, all in favor, carried

Grieser gave monthly Zoning report with 6 new permits issued

New Business:

Behrenwald gave update on P/C meetings and need to republish Wind/Solar 12 month Moratorium in Local paper according to attorney firm

Lindsey reported on list of road repair projects offered by County Road Commission, motion made by Lindsey supported by Lincoln to contract with MCRC for Bale road, Schmeid road, Tamarack road and repair on Youngman road, funding partially with Federal ARPA money all in favor, motion carried

Supervisor announced Salary Resolution for 2022-2023. All Board members to retain previous fiscal year salary.

Cemetery contract with Sexton Bucholtz presented by Clerk, Motion by Lincoln supported by Behrenwald, discussion on wage increase due to fuel and repair costs, new rate \$675 monthly beginning 7-1-22, all in favor, carried

Assessors have requested a one time payment of \$3500 for physical property inspections stating they are behind due to pandemic, motion by Lindsey supported by Behrenwald to decline request , discussion on monthly wage for Assessors did not decrease during pandemic

All in favor, carried.

Motion by Grieser supported by Lindsey to allow Assessors to purchase a camera to be owned by Cato Township , costs not to exceed \$350, all in favor motion carried

Veterans Memorial donation request presented by Clerk, Auditor clarified no contribution can be made using Tax Dollars for the project

Old Business:

Clerk reported on Tamarack Trail, preliminary estimates around \$400,000. No funding at present time however still working with Village Manager and DDA seeking Grants

Water well at Cemetery needs work. Clerk will contact Bartlett/Trayer well service

Clerk contacted McKenna Land Planners for help with Township Master plan. Seeking quotes and coordinating with P/C Chairman Morrow

Motion by Behrewald supported by Lindsey to appoint Brandi Hubbard to Zoning Board of Appeals, other candidate Joe Sweet also present, all in favor motion carried

Motion to Adjourn by Lincoln, supported by Grieser, all in favor
