Dear Lakeview Residents,

In 2018, the Village saw exciting things happen within the community. The Festivals Committee had their first Fall Festival. This event will be returning this year along with Summerfest and Christmas in Lakeview. In September the Village held its first joint community clean up event in partnership with Cato Township. This popular event will be returning this year. Additionally, the Lakeview Dog Park opened in Wiseman Park. This has been a great addition to the community and the Village would like to thank those who donated and were involved in the project.

More improvements are on the horizon for Lakeview's parks. In early 2019 the Village adopted a 5-year parks and recreation plan. This plan makes the Village eligible to apply for grant opportunities with the Michigan Department of Natural Resources. In the coming months, the Downtown Development Authority will begin putting together a grant proposal based on the Shoreline Development Plan.

This year the Planning Commission will continue working on an update to the Village's Master Plan. The Commission will be needing residents and other community members input in this process. Be on the lookout for more information on our Facebook page.

The Village Police Department welcomed Officer Catts as our full-time officer. The Police Department also secured a grant from the USDA to help purchase a new police cruiser.

Infrastructure and asset management continues to be a priority for the Village Council. In 2018 the water tower was given a fresh coat of paint. While this may seem like a simple thing, painting helps protect the tower from corrosion and similar wear and tear. A cleanout of sewer Lagoon #1 will take place this year. Additionally, the Village streets have been rated based on their condition, and Village staff will begin working on a multi-year plan to identify projects and funding strategies to maintain roads in good condition, while also addressing the roads that need maintenance the most.

Finally, the Village would like to thank Pamela Main for her service as the Village Clerk/Treasurer. Main retired last year and the Village welcomed Melissa King, who has been a great addition to the Lakeview team. Additionally, Ed Winter, after 23 years of combined service as Council Trustee and Village President, stepped down in November and David Lund was elected as the new Village President. The Council saw additional changes as Kathy Lobert stepped down from Council after 17 years of service, and Emily Griffith was appointed to fill Kathy's seat. The Village would like to thank Ed and Kathy for their many years of service to the community. Another new face on the Village Council is Greg Saxton. The Village welcomes him to the Council and thanks him for his previous service on the Planning Commission.

In the three months I have served as your Village Manager, I have met many residents and community members who are excited about Lakeview and eager to serve their community. I would like to thank you for welcoming me, and I look forward to serving alongside you for years to come. On behalf of the Village staff, I thank the community for your support and partnership in making Lakeview a place where people love to live, work, and play.

CEMETERY

With spring on its way and Memorial Day fast approaching, many will be visiting the cemetery to freshen grave sites.

Winter blankets, wreaths, artificial flowers, and all other decorative items must be removed by April 15th. You may place authorized items after May 15th. If you have questions about what is considered authorized, stop by the Village Office and Missy will furnish you with a copy of the Rules and Regulations. The Cemetery staff will remove unauthorized decorations, trees, and shrubs, fieldstones and other unauthorized items that have been placed on or around grave sites.

On February 11, 2019, Cemetery Ordinance #2019-3 was adopted by the Village Council. This Ordinance will be effective starting March 16, 2019.

On February 11, Resolution #2019-2, Cemetery Fee Schedule, was adopted and will go into effect on March 16, 2019.

To protect the roads and grounds the DPW occasionally will keep the gate locked. You may still walk in.

HYDRANT FLUSHING

Note the two times that flushing will be conducted. Residents should check their water for redness prior to washing their clothes. The redness is not harmful. It may, however, stain your clothes. If redness occurs please flush your lines for a few minutes and it should clear up. Dates are May 2 and October 3 beginning at 10:00 PM.

SNOW REMOVAL

When you remove snow from your property or driveway, make sure you do not put the snow on the sidewalk or in a street right-of-way.

RATE ADJUSTMENT

Beginning March 1, 2019, you will notice on your water/sewer bill that there is a slight increase. The adjustment, as with the past year, is adjusted to the Consumer Price Index Increase or 2.0%, whichever is the greater of the two.

VILLAGE CLEAN-UP

PLANNED FOR SPRING

The Village will be holding a spring clean-up day. The scheduled day will be April 13th. The drop off times are between the hours of 9:00 AM and 12:00 Noon. If the dumpsters fill before 12:00 Noon, the site will be closed. The dumpsters are located at 10300 North Street. You will be required to show proof of residency. A current water bill or tax receipt will work

No hazardous wastes or Appliances containing Freon will be accepted.

AFTER HOURS EMERGENCIES



It is rare, but occasionally sewer and water problems do happen. If you notice water coming out of the ground that shouldn't be or you have a slow or noisy sewer, don't hesitate to call the DPW. We have an "on call" worker 24 hours a day, seven days a week.

Our DPW will be able to take care of the problem if it is the Village's or can give you direction on how to take care of the problem if it is your responsibility. Problems caught early on are much easier to deal with than when they become an emergency.

BRUSH & LEAVES

There will be a change in our bagged leaf pickup starting in March, 2019. The Village will pick up leaves that are placed in brown paper bags, designed for grass clippings and leaves, through May 30th. This will create a more environmentally sound practice for our Village. The dates for bagged leaf pickup will be in the Village Schedule located in this flyer. A location at the Lakeview Airport will then be available after May 30th for residents to drop off their leaves and waste. Once again, the leaves and clippings MUST be in the brown paper bags.

We ask that bags not be set out curbside before the pickup dates. This will help with the removal of the bags due to weather conditions.

RESPONSIBILITY FOR WATER

AND SEWER LINES

Home owners are responsible for the installation and maintenance cost of the water and sewer line on your property. Plugged sewer lines and leaking water lines are your responsibility.

The Village is responsible to provide the citizens with 35,476,000 gallons of potable water (2015 usage), maintain 65,000 feet of water main, 23,000 feet of service lines, 210 main line valves, over 1,000 service line related valves, 85 hydrants, 478 water meters, the water wells and a water tower.

The Village is also responsible to treat 41,274,333 gallons of raw sewage (2015 usage), and return it to the environment, maintain 44,600 feet of sewer main, 166 man holes, 8 sewer pumps, four pumping stations, 44 sewer control valves, 470 service laterals, five lagoons covering 15 acres and a three acre filtration bed.

Additional responsibilities for the Village include maintaining the water and sewer systems, and maintaining 12 miles of streets, 35,000 feet of sidewalk, over a hundred trees, and remove the brush and leaves from hundreds of trees, two parks, cemetery, airport, 11 buildings, equipment and vehicle maintenance. The list could go on and on but we think that you can begin to understand the immense responsibility the DPW employees have.



CAMP FIRES



There are restrictions! You cannot build a fire that exceeds four feet in diameter. The fire must be a minimum of 40 feet from a street and 20 feet from a building or property line. A person of suitable age or discretion must be present at all times. You must remain in complete control of the fire at all times. Materials burned in any grill or camp fire are limited to wood or charcoal. **You are not allowed to burn garbage, trash, refuge, construction material, brush, grass, or leaves.**

POLICE DEPARTMENT

EYES AND EARS

VILLAGE ORDINANCES

Complete ordinances are available at the Village Office.

Ord. #35: No parking on any Village street between 2:00 AM and 6:00 AM. No parking in any Village parking lot for more than 72 hours.

Ord. #9: An ordinance to prohibit the running of dogs in streets and other public places. Leash is required.

Ord. #94-10: Keeping of Pets. No more than three adult dogs and/or cats in combination shall be kept or housed in one residential unit or property.

Ord. 41: Disorderly Conduct. It is unlawful to lie or sit on sidewalk, sit on steps open to the public, recline in office windows, window sills, or ledges outside of buildings, sit on any exterior surface of a parked automobile.

Ord. 01-03: Prohibition of Unreasonable Noise. It shall be unlawful for any person to create, assist in creating, permit, or continue to permit an unreasonable loud, disturbing noise. Engine exhaust is also included.

Ord. 01-01: An ordinance to establish a curfew for minors. No minor under the following ages shall loiter, idle or congregate in or on any public street, alley, or park between the hours of 10:00 PM to 6:00 AM under 12 years old and 11:00 PM to 6:00 AM for minors under 18 years old.

Ord. 92-1: Dismantled or Inoperable Vehicles. An ordinance to regulate inoperable or dismantled vehicles. Storage of inoperable or dismantled vehicles is not allowed. Vehicles must be operational and must have a valid Michigan registration.

Recycling in Lakeview

Recycling is available at 10300 North Street. These unmanned centers are available for self-serve Monday – Friday 8am – 8pm.

Montcalm County is providing all residents with an alternative direction for recyclable materials that might otherwise be disposed of in a landfill. The items accepted at the recycling centers will be processed and delivered to manufacturing plants to make new products, saving landfill space.

How it works:

Consider whether those items you are throwing into the trash can be recycled. Bring your cleaned materials to the center at 10300 North Street, and simply toss your recyclables into the designated containers.

What can you recycle:

Plastic #1 clear transparent containers only (example: water bottles)

Plastic #2 milk jugs, laundry detergent jugs, softener bottles, etc.

Grocery bags, newspapers, cardboard, and box board (example: cereal, cookie, cracker boxes, etc.)

Glass, aluminum, tin

NOTE:

Plastic containers with numbers 3,4,5,6,7 or no number will not be accepted.

Styrofoam will not be accepted.

Please remove all plastic container caps.

*Note: No unrecyclable material may be disposed of in the center containers.
